

**FINAL ORDER**

**DATED: 19.7.2018**

1. H. B. Kapadia New Primary School, English Medium, Gandhinagar has submitted its proposal with relevant documents. After considering the said proposals along with the documents produced by the School Management, the committee has determined the provisional fees for the academic year 2017-18 and 2018-19 for Playgroup, Nursery, Junior Kg and Senior Kg (GSEB English Medium). The school management has raised its objections stating that while determining the provisional fees, the committee has reduced about 54.66%, 33.33%, 28.00% and 21.33% of fees proposed by the school management for Playgroup, Nursery, Junior Kg and Senior Kg respectively and because of that it is very difficult for the school management to run the school. The school is imparting quality education to the students and hence, the reduction made by the committee in the



fees proposed by the school management is not at all justified. A request was therefore made to grant an opportunity of being heard personally.

2. Considering the said letter of objections, the committee has issued the notice of hearing of objection on 12.7.2018 fixing the date of hearing on 23.7.2018. The committee has also asked for certain details mentioned in the said notice. The committee has also inter alia directed the school management to place the order determining the provisional fees, on its notice board as well as on the website and if any objection against the provisional fees from any parents is received, the same shall be brought to the notice of the committee.
3. Before the date of hearing of objections, a letter dated 18.7.2018 was received by the committee stating therein that the school management has decided to withdraw the objections filed on 3.7.2018 and requested the committee not to proceed with the said objections. It is very surprising that once having raised the objections against the provisional fees determined by the committee and before compliance with the notice issued by the committee, the school management has withdrawn its objections vide its letter dated 18.7.2018. In normal circumstances, the committee would have insisted for due compliance of its notice whereby certain details were called for. However, in absence of any objection received from parents against determination of provisional fees, the committee is inclined to pass final order on the basis of the fees provisionally determined vide its order dated 27.6.2018, subject to clarification that if any objection is received by the committee from any of the parents with regard to the provisional fees determined by the committee, the same shall be considered on its own merits and if necessary, the committee would exercise its inherent jurisdiction for necessary action, after hearing the school management in the matter.
4. Subject to the aforesaid observation, the committee hereby passes the final order as under:

**Terms and conditions:**


1. The school is not permitted to collect fees for the first quarter of 2018-19, more than fees determined for the year 2018-19.
2. The school is permitted to charge fees for the academic year 2019-20 by giving rise of 5% in the final fees determined by the committee for the year 2018-19.
3. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees or term fees and thereby causing extra burden on the students.
4. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
5. If the school management has any grievance against the final fees determined by the committee, it shall have a right to file revision before the Fees Revision Committee within three weeks from the date of receipt of the order and after making payment of Rs.10,000/- by way of filing fees.
6. The school is directed to place the order determining final fees on its notice board as well as on its website.

**CORRIGENDUM IN FINAL ORDER DATED 19.7.2018**

**DATED: 27.8.2018**

The Fee Regulatory Committee has passed the final order on 19.7.2018 determining the final fees for play group, nursery, Jr. Kg and Sr. Kg. On receipt of the said order, the school management has orally drawn the attention of the office that there is an error in mentioning the correct name of the school as well as academic year. Instead of mentioning the name of HBK Kids Pre Primary School (English Med.), the name mentioned in the final order is H B Kapadia New Primary School, English Medium, Gandhinagar and instead of mentioning the academic year 2018-19, in the table given in the order the academic year is mentioned 2017-18 at three places.

In the above view of the matter, the committee hereby thinks it fit to make necessary correction in the final order passed on 19.7.2018 by changing the name of the school from H B Kapadia New Primary school, English Med. , Gandhinagar to H B K Pre Primary School (English Med.), Motera, Dist.

Gandhinagar and from academic year 2017-18 mentioned in the table at three places to academic year 2018-19. Thus the first three columns of the table are for academic year 2017-18 and the remaining three columns in the table are for academic year 2018-19.


Subject to the above clarification, final order passed by the committee on 19.7.2018 for the academic year 2017-18 & 2018-19 shall remain the same.
