#### READ:-

- 1. Proposal submitted by The H. B. Kapadia New High School, Opp. Tirth Nagar-II, Memnagra, Vishram Nagar, Gurukul Road, Ahmedabad-382418 for academic year 2017-18 and 2018-19 for Grade I and Grade II (Cambridge English Medium) along with relevant documents.
- 2. Provisional order passed by the Fee Regulatory Committee on 5.10.2018.
- 3. Notice issued by the committee on 2.2.2019 directing the school to raise objections, if any, against the provisional order.

# FINAL ORDER DATE: 19/03/2019

- 1. Proposal was submitted by The H. B. Kapadia New High School, Opp. Tirth Nagar-II, Memnagra, Vishram Nagar, Gurukul Road, Ahmedabad-382418 for academic year 2017-18 and 2018-19 for Grade I and Grade II (Cambridge English Medium) along with certain documents. After considering the said proposal as well as the documents attached therewith, the Fee Regulatory Committee has passed a provisional order determining the provision fees for Grd I at Rs. 45,000/- for the academic year 2017-18 and Rs.47,250/- for Grd I and II for the academic year 2018-19.
- 2. Since no objections were raised by the school, the committee has issued the notice on 02.02.2019 informing the school that as per the directions of Hon'ble Supreme Court, the school is supposed to raise objections, if any, within one week form the date of receipt of the order. Since, more than four months passed and yet the school has not raised any objections, the committee has proposed to pass final order on the basis of the Provisional order. The school was therefore requested

either to give its consent for passing such final order by the committee or to raise any objection within one week from the date of receipt of the said letter, failing which the committee would pass the final order on the basis of the Provisional Order. The committee has also made it very clear in the said notice that if nothing was heard from the school within one week from the date of receipt of the said letter, the committee would pass the final order for the academic year 2018-19 on the basis of the provisional Order already passed by the committee on 5.10.2018. The committee has also made it clear that if any objection is raised by the school, the same would by duly supported by necessary details and documents.

3. Despite receipt of the above notice, the school has not raised any objection nor given its consent to the Provisional Order till this date. The committee is therefore constrained to pass Final Order on the basis of the Provisional Order and also on the basis on the document available on the record. While passing the Provisional Order, the committee has observed as under; "while looking at the details of expenditure for the academic year 2017-18, it appears that the school has claimed salary and allowances at Rs.55,62,421/- and activity expenditure at Rs.14,58,761/-, the school has also claimed expenditure for maintenance at Rs.14,77,096/-, expenditure on books at Rs.5,43,538/-, expenditure on transportation at Rs.1,07,412/-, miscellaneous expenditure at Rs.20,02,343/- which inter alia include depreciation of Rs.2,95,898/- conveyance expenses of Rs. 1,79,210/-, legal expenses of Rs.1,55,220/-, office expenses at Rs.2,95,690/-, etc. it appears that the exact number of students in academic year 2017-18 is not given, however, in the academic year 2018-19, the strength of the students is 408 and if the total expense are divided by number of students, the expense per student would hardly come to Rs.32,407/- as against which the school has proposed fees of Rs. 80,000/- fir academic year 2017-18 and Rs.88,000/- for academic year 2018-19. The fees proposed by the school are therefore, very excessive and exorbitant. Even if it is assumed that in academic year 2017-18, the number of students is less than the number of student in academic year 2018-19, even in that case, the proposed fees of Rs.80,000/- are not justified on any count."

4. The above facts stated and observations made by the committee in its Provisional Order are neither disputed nor controverted by the school. The committee is therefore of the view that the provisional fees determined by the committee are acceptable to the school. The committee therefore determines the final fees for the academic year 2017-18 and 2018-19 as under:

#### Terms and conditions:

- 1 The school is permitted to collect fees for 2018-19, after giving rise of 5% in the final fees determined for the year 2017-18.
- 2 It is further made clear that the School is not permitted to collect under any head other than the head of tuition fees, term fees as permitted and admission fees of 1 month only in case of new admission and thereby causing any extra burden on the students. However, total of all these fees should not exceed the final fees determined by the committee.
- 3 It is also made clear that the School should either return the excess fees collected by the School for the year 2017-18 and 2018-19 or give adjustment thereof, in the remaining quarters of 2018-19 or 2019-20.
- 4 Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.

- 5 If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application before the Fee Revision Committee along with challan of Rs.10,000/- by way of filing fees.
- 6 The School is directed to place the order determining the final fees on its notice board as well as its website.
